TERMS AND CONDITIONS

1. Auction will start at reserve price 50,000/- fixed by O/o PSACS for all items together.
2. 10% of Reserve Price (5000/-) will be deposited as EMD preferably in form of DD in favor of "Punjab State AIDS Control Society or cash before taking part in auction. Party can not take part in auction process without depositing EMD.
3. Incremental bid value is minimum Rs 500/-.
4. All items will be auctioned together not individually one by one.
5. Auction will take place at the time and date 27-10-16-11 AM only as given in advertisement. No extra time will be given except due to unavoidable official reasons.
6. Any effort made by party to influence auction process in any manner, such party will be straight way disqualified from participating in auction process and his EMD will be forfeited.
7. After completion of auction, successful bidder will have to deposit 25% amount of auction price immediately , after adjusting EMD amount. Balance 75% price will be deposited with in 48 hours and before lifting of goods/items.
8. If successful bidder does not lift goods within stipulated time, his deposited amount will be forfeited and 2nd highest bidder will be negotiated to lift the goods at highest bid/auction price.
9. Unsuccessful bidder will be refunded their entire deposited amount of EMD after completion of auction process/related formalities.
10. If there seems to be any collusion during auction process within bidder with an intention to exploit situation or cause loss to O/o PSACS, entire auction process will be stopped and EMD of all parties will be forfeited.
11. After taking possession of items, acceptance report/signed consent has to be given by party.
12. PSACS reserves the right to postpone or cancel auction process at any stage.
13. Any tax/ duties/levies etc shall be paid by successful bidder
14. Sale of items would be made in favour of single successful bidder who has quoted the highest rate equal or above to the reserve price.
15. Participation in auction for buying items shall be treated as acceptance of all the terms and conditions
16. All other expenses related to lifting, loading/unloading, labour, transportation, carriage etc (to and from) will be borne by successful bidder.
17. There should be at least three (3) eligible bidders to start the auction process. If number of bidder is less than 3 then auction process would be cancelled and EMD will be refunded.
18. All the items will be sold on "AS IS WHERE IS BASIS" will be deemed to have been on the clean understanding that bidders/parties have satisfied themselves full with respect to quantity, quality, conditions, specifications/usage of each and every item/material etc.
19. There is no guarantee/warranty applicable to any item/material and PSACS will not be responsible for anything once bidder/party has taken possession of goods and settlement has been made in this regard like deposit of auction price.
20. PSACS will not be responsible once party has given consent for items inspected by them before commencement of auction and deposited required EMD for respective items.
21. Final decision will be taken by Project Director, PSACS.
22. In case of any disputes, jurisdiction will be Chandigarh only.
