(Document Verification-Recruitment of Medical Lab. Technician at STI State Reference Centre (SRC) Govt. Medical College Amritsar

The Punjab State AIDS Control Society has invited online applications vide recruitment notice No. PSACS/Admn/2024/561 Dated 28.11.2024 for filling up the vacant post of Medical Lab. Technician at STI State Reference Centre (SRC) Govt. Medical College Amritsar on Contractual Basis under National AIDS Control Programme. The advertisement was given in the leading newspapers (Punjabi, Hindi and English) on 29.11.2024 and the last date of submission of application was 10.12.2024.

In response to the advertisement, total 17 candidates have applied through online mode for the above said post on or before due date i.e. 10.12.2024 as per the TORs of advertisement. Instructions for document verification (only for candidates mentioned in the Table "B"):

- The candidates are required to bring **original documents/certificates** comprising Academic certificates, experience certificates, Proof of passing Punjabi upto Matric standard or its equivalent standard from any recognized institution/Board or proof of passed the Punjabi Language Proficiency Test conducted by the Department of Languages, Government of Punjab, category certificate issued from Punjab Govt, Age proof and Photograph alongwith photocopy of all testimonials.
- If candidate has mentioned experience of working in accredited labs or those labs who have applied for accreditation, will have to submit the certificate from the laboratory.
- **Additional time shall not be given to submit the certificates/testimonials.**
- In case **candidate fails to produce any certificate/testimonial or found fake/forged on the day of document verification, the eligibility would be cancelled with immediate effect.**
- Candidates will not be paid any TA/DA for attending document verification.
