The Punjab State AIDS Control Society has invited online applications for filling up the vacant post of Divisional Assistant in Blood Transfusion Services (BTS) division of PSACS Head Office Chandigarh. - Additional time shall not be given to submit the certificates/testimonials.
- In case candidate fails to produce any certificate/testimonial or found fake/forged on the day of document verification, the eligibility would be cancelled with immediate effect.

Candidates will not be paid any TA/DA for attending document ventication.
