1. For the post of Medical Officer:

- ✓ Candidates must ensure to bring their resume along with original testimonials related to Qualification, Experience, Punjabi upto Matriculation, Category, Age proof etc. and one self attested photocopy of all such documents for submission. The candidates must also bring 2 latest passport size photographs at the time of interview.

2. **For the post of Care Coordinator:-** Interested candidates having the qualification mentioned against the post mentioned in **Table “B”** may send their application in the office of Punjab State AIDS Control Society, Prayaas Building, 4th Floor, Sector-38-B, Chandigarh on the prescribed format along with the attested copies of the certificates/testimonials and two recent passport size photographs. The last date for receipt of applications is **27-11-2020**. **Applications received after closing date will not be considered.**

3. The maximum age limit for the post of Medical Officer is 65 years and Care Coordinator is 60 years.

4. Candidates should have passed subject of Punjabi upto Matric standard. If not passed, candidate must submit an undertaking to pass Punjabi subject within 6 months of joining.

5. Degree/Diploma should be from a recognized University or Institute.
6. **For the post of Care Coordinator:-** Short listed eligible candidates will be called for document verification. Original certificates/testimonials will be checked at the time of document verification.
7. Any candidate is found not to be fulfilling the eligibility/selection criteria at any point of time in the entire recruitment process by the screening or selection committee, his/her candidature will be cancelled/ rejected for the said post.
8. Candidates will not be paid any TA/DA for attending the interview.
