# **Recruitment Notice for the post of Data Manager**

The Punjab State AIDS Control Society (PSACS) invites online applications on prescribed proforma for filling up of vacant post of Data Manager on Contractual Basis under National AIDS Control Programme of Punjab State AIDS Control Society (PSACS) ) in Anti-retroviral Therapy (ART) Centres and Opioid Substitution Therapy (OST) Centres. The last date of submission of application is **24-12-2023** 

**Number of vacancies:** There are four (4) vacancies to be filled strictly based on the reservation roster. Table 1 below provides the total and the category-wise number of vacancies. Candidates from other categories shall not be considered. The reservation is strictly as per provisions of the Punjab Government reservation roster.

**Salary**: The Data Manager shall be paid a consolidated salary of Rs.21,000/- per month.

**Maximum age limit:** The maximum age limit to apply for the post of Data Manager is 60 years.

**Educational qualification:** The essential and additional qualification for the post of Data Manager is show in the Table 2.

The applicant should fulfill the eligibility requirements on or before the last date of submission of applications i.e. 24-12-2023 (last date of online Registration). No extension shall be given to any applicant to submit documents. If a candidate does not have eligibility documents such as category certificate issued by concerned department of Government of Punjab (or) educational degree then they will be declared ineligible at the time of document verification.

Note:- While filing online application form candidate have to give self-assessment score based on your assessment of essential and higher educational qualifications after evaluating the scoring sheet as per below selection criteria.

#### **Selection Criteria:**

- 1. The selection of candidates is based on essential and higher qualification.
- 2. Regular degree programmes are given higher scores than correspondence/distance education. Having educational qualification completed as regular or distance/correspondence mode, higher scores are given to regular course and then correspondence/distance.
  - Further, if a candidate has a higher educational degree then additional marks are given. Candidates have to assess their own scores based on their educational qualification.
- 3. The selection of candidates is based on objectives criteria for essential and additional qualification as shown in Table 3.

- 4. Self assessed scores of all candidates will be displayed on PSACS website and in public domain. Candidates submitting incorrect information will be debarred and their candidature will be rejected.
- 5. Candidates will be invited and then documents will be checked and the self evaluated scores and committee evaluated scores will be compared. Candidates must bring all documents and the proof of burden to justify self evaluated score will lie with candidates. In case of any difference of opinion between self-evaluated score and PSACS committee evaluation Project Director, Punjab State AIDS Control Society will be the final authority.
- 6. Candidates with the highest score will be invited for a presentation on a topic, they will be tested for their typing speed and will be asked to present on a topic using PowerPoint.
- 7. If candidates after self evaluation have similar scores, inter-se-merit shall be determined on the basis of their aggregate scores obtained in essential/ higher qualification.

## Please see below detailed explanation of terms used in table 3:

# • Regular:

Regular education involves attending classes on a physical campus, interacting with professors and peers in person, and participating in various extracurricular activities. It offers a structured curriculum with set schedules for lectures, exams, and assignments.

# • Correspondence/Distance education

Correspondence and Distance Learning is a system wherein teachers and learners need not necessarily be present either at the same place or same time and is flexible in regard to modalities and timing of teaching and learning as well as the admission criteria without compromising necessary quality considerations (Department of Higher Education, Government of India).

- b. The candidate should have passed Punjabi up to Matric standard or its equivalent standard from any recognized institution/Board or should have passed the Punjabi Language Proficiency Test conducted by the Department of Languages, Government of Punjab.
- c. Incomplete applications will be rejected.
- d. Only on-line application forms will be entertained i.e. application sent by email/post/in person in the O/o PSACS will not be entertained and will be rejected.

- e. All particulars including category once filled by the candidates, could not be modified and no change shall be permitted at any stage of online application form. So, the candidates are advised to fill all their particulars after taking due care and precaution. PSACS shall not be responsible or liable in anyway.
- f. The number of posts is subject to **increase or decrease** as per the decision of the Project Director, PSACS.
- g. The certificate for the **claim of reservation** must be issued by the **competent authority**. The certificate must be latest one i.e. issued on or before the last date of submission of application form. No request for extension of submission of documents will be considered.
- h. These posts are purely **contractual and temporary for one year**, extendable based on work performance and conduct.
- i. Educational qualifications must be from a recognized University/Board. You should have all the requisite original certificates at the time of submission of the application. Additional time shall not be given to submit the certificates/documents.
- j. Top 5 candidates from each category as specified in the **Table-1** will be called to appear in person for **document verification**. **Original certificates/testimonials** will be checked at the time of document verification. **Additional time shall not be given to submit the certificates/testimonials**.
- k. If found eligible after document verification, you will appear in person for the computer typing / presentation in the O/o PSACS on the same day of document verification.
- l. If a candidate is found not to be fulfilling the eligibility/selection criteria at any point of time in the entire recruitment process by the screening or selection committee, his/her candidature will be cancelled/rejected for the said post.
