Result Order (Recruitment of Data Manager)

In continuation of the office order No. PSACS/Admn/2023/915 Dated 08.01.2024, 10 candidates of Scheduled Caste Category, 8 candidates of Physically Handicapped, 1 candidate of Ex-Serviceman (Female) category and 10 candidates of General EWS (Female) category were called for document verification and computer test on 15.01.2024 & later 36 more candidates belonging to General EWS (Female) category were called for document verification and computer test on 18.01.2024 in the O/o Punjab State AIDS Control Society.

Out of above called candidates, only 5 candidates of Scheduled Caste Category, 3 candidates of Physically Handicapped Category and 9 candidates of General EWS (Female) appeared for document verification and computer test in the O/o PSACS and no candidate of Ex-Serviceman (Female) appeared for document verification and computer test.

- a) Currently, there were 4 (Four) posts of Data Manager that will be filled strictly based on the reservation roster. These posts will be filled for ESM (Female)-1, Gen(EWS) Female-1, Physically Handicapped/F (By rotation)-1, SC-1. None of the eligible candidates belongs to ESM (Female), hence, the post under this category shall remain vacant as per the extant instructions of the Department of Defense Services Welfare, Punjab.
- 1.0 Scheduled Caste: Table 3 shows the merit list based on document verification held on 15.01.2024. Out of the following 5 candidates, the first candidate is selected against the one post of SC and the remaining candidates are kept on the waiting list.

Note: Since the candidates at Sr.No.1, 2 & 3 in the Table-3 above have similar Total Marks (Self issessment score + Presentation), so as per selection criteria mentioned in the recruitment order the candidate at Sr.No.1 is selected on the basis of the percentage in the essential qualification i.e. Graduation.

1.2 General EWS (Female): Table 5 shows the result of the following candidate based on document verification held on 18.01.2024 of one candidate.

Note: The scrutiny committee has reassessed the self-assessment score of the above mentioned candidate (Table-5 above) which comes out 40 (on the basis of information provided by candidate while filling online application form) instead of 20 (score assessed by the candidate herself) before document verification. During the document verification held on 18.01.2024, after assessment of documents by committee members, the revised self-assessed score of candidate is calculated as 25. Now, since there are other candidates with similar self-assessed score of 25 but having higher percentage in the essential qualification i.e. graduation. So, the above mentioned candidate could not be selected presently. The remaining candidates belonging to Gen EWS (Female) category will be called for document verification and presentation in the month of February and the appointment letter will be issued to the eligible candidate based on merit.
