In continuation of the office order No. PSACS/Admn/2023/863 Dated 26-12-2023, 27 candidates (Gen-EWS 10, SC-Female 10, BC-ESM 7) who cleared the written test held on 17-12-2023 at Dr. B.R. - b) Currently, there are 12 (Twelve) posts of Staff Nurse that will be filled strictly based on the reservation roster. These posts will be filled for ESM (Female)-2, Gen(EWS) Female-2, Physically Handicapped/F (By rotation)-1, ESM-1, Gen(EWS)-2, SC(ESM)-1, Sportsman (Female)-1, BC (ESM)-1 and SC (Female)-1. None of the eligible candidates belongs to ESM (Female), Physically Handicapped, ESM, Sportsman (Female), SC(ESM) and BC (ESM), hence, the post under these categories shall remain vacant as per the extant instructions of the Department of Defense Services Welfare, Punjab, Department of Social Justice, Empowerment and Minorities, Punjab and Department of Sports, Punjab and Deptt. of Social Security and Women and Child Development, Punjab.
  - 1.0 General (EWS) (Female): Table 3 shows the merit list based on written test scores and document verification of four (4) candidates. Of these four candidates, the first two candidates in merit is selected against the two posts of Gen (EWS) (Female) and the remaining candidates are kept on the waiting list.
