- **Printing Instructions:-** All labels of cartons/boxes etc. should be emboldened/imprinted/stamped "**Govt. Supply - NOT FOR SALE**". MRP should not be written/printed on the supplies. No supply will be accepted without these printing instructions.
- The articles shall be of exact specified quality, kind, description and specification as demanded. The **compliance of technical specifications (Copy Enclosed) must be ensured/cross checked before delivery**. If the supplier fails to supply the goods as per specifications, the supply will be rejected.
- The reagents/chemicals should be of long expiry date. The short expiry material will not be accepted and if there is any reaction of the reagents/chemicals due to expired date, then the supplier will be responsible for all the consequences thereof.
- That in case of any query raised by the end user, the supplier will be responsible to deal with the query to the entire satisfaction of the user.
- **Payment Terms:** The bill should be raised in duplicate. The payment will be processed after the inspection of supply and issue of consignee's acceptance and receipt report. The **Supply Order No., Date** must be mentioned on the invoice. The **GST No. 04AAAJP0147M1DG** of Society should be mentioned on the invoice.
- **Penalties of late supply:** If the supply is not made within the stipulated period, then late delivery charges @2% will be imposed upto 30 days and thereafter 4% for another 30 days after which the supply order will be cancelled and company will be blacklisted for future.
